- 5. 100% of the shares subject to the option vest on the first anniversary measured from June 29, 2020.

The Reporting Person, a Senior Advisor of The Blackstone Group Inc. ("Blackstone") or one of its affiliates, is a member of the board of directors of the Issuer. Certain affiliates of Blackstone have filed a separate Form 3 reporting securities of the Issuer that they may be deemed to beneficially own. The Reporting Person disclaims beneficial ownership of any securities of the Issuer that may be deemed to be beneficially owned by affiliates of Blackstone.
